## ELIGIBILITY

Entries are open to teams of amateur female golfers who: a) are members in good standing of a WSGA member club; b) each have an active GHIN number and USGA Handicap Index, issued by a WSGA member club, not exceeding 40.4 at the time of entry; and c) partners' course handicaps must be within 8 strokes of one another or an adjustment will be made to the higher player's course handicap to meet this requirement. The maximum allowable course handicap will be 36 (players above this will be reduced to meet this requirement).

## AGE

No age requirements.

## ENTRIES

Entry applications can be filed online at [www.thewsga.org/championships](http://www.thewsga.org/championships) with a credit card, or by mail with a completed paper application form and check or credit card authorization form. Payment will be processed at the time of entry. A full refund will be issued to entrants who are placed on a waiting list and do not make the starting field.

Entry applications, along with the appropriate fee, must be received by the WSGA by 4:30 p.m. on May 6, 2019. Refunds due to cancellation on or before May 6, 2019 are subject to a \$10 service fee. After May 6, 2019 and up until round one pairings are released, refunds for documented and approved medical reasons are subject to a \$25 service fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASED.**

Late entry applications may be accepted and used to fill spots if they become available up until a time that the WSGA staff establishes. Late entry applications will not be accepted unless they are accompanied by the correct entry fee, plus an additional administrative fee of \$25. Contestants must contact the WSGA in order to submit a late entry application.

## CONDITIONS

The WSGA Champion of Champions Committee reserves the right to alter any of the conditions and schedules herein. The Committee reserves the right to reject the entry of any applicant, at any time, for any reason. Any decision by the Committee, in any matter, shall be final.

## CODE OF CONDUCT

Unacceptable conduct or behavior on the golf course or on club property will not be tolerated and may be subject to disqualification under the WSGA Code of Conduct at any time, from any WSGA Championship. **The WSGA Code of Conduct will be provided to all contestants prior to the Championship.**

## CARTS

The use of automotive carts during the championship is permitted. Cart fees are \$80 per team, includes both rounds, and must be paid during registration. Spectator carts will not be permitted.

## CADDIES

A player may provide his own caddie. Host club caddies will not be available.

## DRESS CODE

The WSGA expects all contestants and their caddies to wear suitable attire on the host club property throughout the duration of the championship, including practice rounds. The full WSGA Dress Code Policy can be found online at [www.thewsga.org/policies](http://www.thewsga.org/policies) and will be provided to all players, along with any additional measures required by the host club, after the entry deadline. Gallery must adhere to the host club dress code policy. Failure to adhere to the dress code may result in disqualification and removal from the course.

## PRACTICE ROUND

All contestants will be allowed one complimentary practice round prior to the championship. Consideration will be made for out-of-town players with regard to reserved starting times the day prior to the championship. Contestants can reserve practice round times directly through the golf shop. All practice round times are at the discretion of the golf shop staff.

## CHAMPIONSHIP SCHEDULE

36-hole, Four-Ball Stroke Play (Best-Ball). Teams will be flighted based on course handicap with gross and net awards.

In the event of a tie for the gross championship, the winner will be decided immediately by a hole-by-hole playoff.

## WITHDRAWAL POLICY

All refunds prior to the entry deadline are subject to a \$10 administrative fee. Refunds are not available after the closing deadline except for documented and approved medical reasons. Refunds approved after the closing deadline, and up until round one pairings are released, are subject to a \$25 administrative fee. **NO REFUNDS WILL BE ISSUED AFTER ROUND ONE PAIRINGS HAVE BEEN RELEASED.**

During play of the championship, a competitor must notify WSGA staff and state her need to withdraw. Entrants who unofficially with-draw (by not notifying the WSGA staff or without having sufficient reason to withdraw) will not be granted entry into any future WSGA championship for a minimum of two years.

## LODGING

The WSGA recommends that contestants make their lodging arrangements at the earliest possible date. The WSGA provides highly discounted rates on hotels as a part of the "WSGA Rewards" program. Contestants can access hotel bookings in close proximity to the golf course using their GHIN number online at [www.thewsga.org/rewards](http://www.thewsga.org/rewards).

## CHAMPIONSHIP EXEMPTIONS

A place in the field will be reserved for the **2018 Women's Best-Ball Champions: Victoria Fallgren and Leslie Folsom**, until May 6, 2019. **Note: The team must be made up of the same players in order to receive the exemption.** All entries submitted after this date will be accepted in the order they are received (*Exempt players must meet the eligibility requirements of this championship*).
